**Special Rules and Regulations for Fine Arts**

(See General Rules for further instruction)

1. All artwork must be original and within a specified class; Computer generated, photographic, digital prints, and copies are prohibited.
2. Online entry only. Submit Photos at [www.azstatefair.com](http://www.azstatefair.com) Photo must be 5MB or less and in .jpeg .gif .bmp .png only.
3. Images must be in RGB color format and minimum image dimensions (width or height) should be 400 pixels.
4. No refunds will be issued for items incorrectly entered by the exhibitor or for juried-out entries.
5. Fine Art entries will be judged first from uploaded images viewed online to determine if the submitted photo entry meets the standards and guidelines of the contest. This is the jury process and first round of judging.
6. Accepted entries are judged in person by a panel of judges for the second round of judging.
7. First round judging acceptance does not guarantee displaying of the art at the exhibit.
8. Entries must be from an individual artist; no groups.
9. Exhibitor must be an Arizona resident for at least six months of the calendar year.
10. Entries must be recent work created within the past two years (September 2017 – September 2019).
11. All works that have been previously submitted to the Arizona State Fair are prohibited.
12. The subject matter for each entry must be appropriate for the family nature of the Fair (no nudity or violence).
13. Entries must be submitted before the online deadline as well as delivered before the judging deadline. Late entries or deliveries will not be accepted.
14. Each entry must be properly labeled with exhibitor information, category, and class.
15. Entries must be a single piece, unpacked, framed or canvas wrapped, and wire hung with an optional one layer of glass (no exceptions).
16. Entries cannot exceed 60 inches in any dimension or weigh more than 50 pounds.
17. Exhibitors are responsible for determining which division and class they wish to compete. Improperly classified entries will be disqualified with no entry fee refund given.
18. Judges are selected from the Arizona Art Community whom have proven expertise in the artistic medium they are judging.
19. Judging is closed to the public and all judging is final.
20. Classes with less than eight entries may be combined with other classes for judging and awards purposes.
21. All artwork will be exhibited in the Fine Arts Area or an area designated by the fair staff the entire duration of the Fair and may not be removed early.
22. All artwork must be picked up during designated pick up times. Due to lack of storage; Items not picked up by the deadline will be charged a \$25 handling fee and a \$1/day storage fee. Items not collected within 30 days will be donated or removed from the Fair Grounds.
23. Premiums/Cash Prizes will be paid to the artist at item pickup or remitted within 60 days from the close of the Fair.
24. The Arizona State Fair will take all reasonable care of the artwork while part of the exhibition and will provide liability protection against damage or theft of the artwork while in its possession but may request proof of cost.

**FINE ARTS EXHIBITORS PLEASE NOTE:**

Exhibitors within the Fine Arts Department can compete within one of three divisions: Amateur, Professional (Receives payment for art work) and Person(s) with Disabilities. **Be sure to indicate the correct division on your entry form.** If exhibitor is less than 18 years of age, include your age and your parent signature where indicated. Failure to comply with these rules may result in disqualification of the entry.

**Arizona Artists Guild (AAG) Veteran’s Special Contest**

- Any AZ resident who is a Veteran of US Military service is invited to submit one piece of 2D or 3D artwork. Contest is limited to the first 100 entries.
- Entries must be a single piece, unpacked, framed or canvas wrapped, wire hung, with an optional one layer of clear glass.
- 2D artwork may not exceed 60 inches in any dimension, 3D artwork must be free standing and not weigh more than 50 pounds.
- Any theme or subject (excluding violence or nudity).
- AAG Veterans Competition entries cannot be sold at the Fair; however, interested parties will be directed to contact the artist.
- Artwork not picked up by November 2, 2019 will be subject to a \$25 handling fee plus a \$1/day storage fee. Items not collected within 30 days will be donated or removed from the Fair Grounds.
- The artist’s name, address, phone number and email address must be attached to the artwork on the rear of the artwork.

### Frequently Asked Questions:

**Is my entry considered Fine Art or Home Art?**

Fine Art is any visual art considered to have been created primarily for esthetic, and intellectual purposes and judged for its beauty and meaningfulness. To be successful in this distinction, the artwork must demonstrate originality, artistic technique, and quality execution. Functional art, applied arts, crafts and similar items should be submitted to the Home Arts Department. Unfortunately, due to the number of entries, if a submission is not considered Fine Art it will not be automatically transferred to the Home Art Department and will not be judged or displayed.

**How do I know which division to enter?**

The Amateur Division includes any artist who has not previously, and does not currently sell their artwork. The Professional Division is for artists who have previously, or do currently sell their artwork.

**How do I know which class to enter?**

Artwork classes are categorized by medium. Each entry must correspond to an existing class. Some general guidelines include: If the entry contains more than one medium, it should be entered into the Mixed Media class. If the entry is 3 dimensional (excluding ceramics), it should be entered into the Sculpture class.

**May I enter a piece into more than one class or division?**

No, each entry must be for one division and one class.

**If my art is sold at the Fair, how does that work?**

The Arizona State Fair is proud to offer the opportunity for artwork to be displayed as well as sold at the Fair! If an entry is for sale, it must be clearly labeled as "for sale" on its entry tag as well as a price provided. Prices must be a specific amount; no ranges are permitted. There will be no negotiations between the buyer and the artist for sale price. Buyers are on a first come, first serve basis. Buyers will indicate which piece they would like to purchase and pay those monies to the Fine Arts Coordinator. The Fair will collect a 10% sale commission and the balance of the purchase price will be given to the artist at entry pick-up, or remitted within 60 days from the close of the Fair. Despite being sold, artwork must remain on display until the close of the Fair. Distributing the artwork to buyers will be the responsibility of the Fine Arts Coordinator.

**When will entry forms be available and due?**

Entry forms will be available online only and must be submitted through the online entry program. Once entered through program, exhibitor must submit a photo of their work for the 1<sup>st</sup> round of judging. Online entry is due September 13, 2019 at 10:59 pm.

**Who are the judges?**

The judges are Artists from the Arizona Art Community. Judges are selected based on their expertise within their category as well as their involvement with the Arizona Art Community.

**How does judging work?**

Judging is closed to the public. This is a two tiered judging system. The first round of judging takes place online once photos of artwork has been submitted. Once first round of judging has taken place, exhibitors will be notified via email of their artworks acceptance into the show. At this point, the artists who have passed the 1<sup>st</sup> round of judging will prepare and submit their artwork to the fair by the deadline. Once entries have been received and categorized, they will be anonymously submitted to the judges for review. Judges will use the American System and premiums will be limited to two per class. All judging is final. The judges may be available during the Fair for questions. If you are interested in being a judge for the 2020 State Fair, please contact the Coordinator of Fine Arts.

**When will pieces need to be delivered to the Fair?**

Once an entry has been accepted into the fair, the exhibitor will be responsible for delivering the physical artwork to the Fair Grounds between September 20 and September 21, 2019. Any entry that is delivered late, despite the acceptance of the entry will be rejected.

**What are the requirements for my physical exhibit?**

A qualifying entry must not be larger than 60 inches in any dimension, or weigh more than 50 pounds. All artwork must be delivered unpacked, framed and wired. If the nature of the piece permits it from being framed, it must be canvas wrapped and wired.

**Is there an opportunity to meet the other artists?**

Yes! We are excited to host an Artist Reception in which exhibitors, judges, and members of the Arizona Art Community will be celebrated.

**How much does it cost to enter?**

In an effort to encourage as much participation as possible, entry fees are nominal at \$5 for the Amateur Division, \$15 for the Profession Division and \$1 for the Person(s) with Disabilities Division.

**How many pieces am I allowed to enter in a given year?**

Each artist may enter a maximum of five pieces within each class; premiums are limited to the highest two within a class.

**How is the Director’s Award awarded?**

The Director’s award takes the 1<sup>st</sup> place entries within the 11 categories of art and judges them against each other. All 11 may not be awarded.

**How will I know if I won an award or sold my piece?**

Each entry that has placed or received an honorable mention will be displayed with its corresponding ribbon. If your piece is sold, you will be contacted by the Fine Arts Coordinator.

**Isn’t art about self-expression; why are nudity and violence prohibited?**

At the Arizona State Fair, we as artists understand and validate that some of the most profound and beautiful artworks throughout history have exemplified nudity or depicted violence. We are expecting over one million attendees this year from all ages and walks of life. In order to make our Fair-goers feel safe and comfortable bringing their families through the exhibit, we ask that all subject matter be appropriate for children.

**Where will my entry be displayed?**

Fine Art Exhibits will be displayed in the northwest corner inside the Coliseum. The particular location of each entry will be determined by the Fine Arts Coordinator.

**Fine Art** - Any visual art considered to have been created primarily for esthetic, and intellectual purposes and judged for its beauty and meaningfulness. To be successful in this distinction, the artwork must demonstrate originality, artistic technique, and quality execution.

**Original Artwork** - A work that has been conceived and executed without the repetition of another artists' work. A piece of art may be inspired by or reference another artwork but should be transcended or be transformed into a new original thought or concept. Tracing, patterns, recreations, and any other violations of another artists' intellectual property are prohibited.

**Artistic Medium** - Art categorized by the materials in which it is made (ex. Glass).

**Sale Price** - The price, determined by the exhibitor, that the Fair is authorized to sell their artwork for.  
**Fair Commission** - The portion of the sale price that the Fair collects to cover administration of sales (10%).

**Amateur** - An exhibitor who has not previously, and does not currently sell their art work.

**Professional** - An exhibitor who has previously, or currently does sell their artwork.

**Painting** - The practice of applying paint, pigment, color or other medium to a surface. The medium is commonly applied to the base with a brush but other implements, such as knives, sponges, and airbrushes can be used.

**Ceramics** - Objects of fired clays. Examples: earthenware, stoneware, porcelain.

**Sculpture** - The branch of the visual arts that operates in three dimensions. Durable sculptural processes originally used carving (the removal of material) and modelling (the addition of material, as clay), in stone, metal, ceramics, wood, and other materials but, since Modernism, there has been an almost complete freedom of materials and process.

**Mixed Media** - A piece of artwork that uses two or more mediums, and for the purposes of this competition is 2D

**Glass Art** - Art made from glass including stained glass, fused glass, blown glass, and glass mosaics.

**Wood Art** - Art made from wood including wood burning and carving.

**Metal Art** - Art made from metal including steel, iron, precious metals; that for the purposes of this competition exclude jewelry.

**Graphic Art** - The arts that rely more on line or tone than on color including printmaking, cartooning, caricatures, calligraphy, and illustrations.

**Fine Jewelry** - Items considered to be fine jewelry are constructed of gold, sterling silver, or platinum. Both yellow and white gold must be at least 10 karats or higher to be classified as fine jewelry.

**Fiber Art** - Fiber art refers to fine art whose material consists of natural or synthetic fiber and other components, such as fabric or yarn. It focuses on the materials and on the manual labor on the part of the artist as part of the works' significance, and prioritizes aesthetic value over utility.

**Drawing** - A picture or diagram made with a pencil, pen, or crayon rather than paint, especially one drawn in monochrome.
