

ARIZONA STATE FAIR EXHIBITOR ENTRY - Signature Release form

Market animal entries must be submitted online. This form must be signed by the exhibitor, the exhibitor's parents or guardian and the leader. No entry is valid until approved by exhibitor's Club Leader or Advisor. Entry fees must be paid before entry will be accepted.

We, the junior exhibitor and parent/guardian, certify that we have read, acknowledge, accept and will abide by all the rules of Arizona State Fair (AZSF).

MARKET ANIMAL WHOLESOME MEAT ACT

We further certify that we have not administered to this MARKET BEEF, MARKET LAMB, MARKET HOG, or MARKET MEAT GOAT, (circle one) entry, **nor has it received, nor will we administer, any substance not approved by the Food and Drug Administration (FDA) and/or the U.S. Department of Agriculture (USDA) for slaughter animals and/or by the AZSF.** This includes, but is not limited to, diuretics, steroids, tranquilizers, and all over the counter pain relief medicines. We also certify that, with respect to any drug chemical or feed additive approved by the FDA and/or USDA, the withdrawal period applicable thereto as recognized by the FDA has expired or will expire, **prior to weigh-in and/or entry at the AZSF.** We acknowledge and accept the fact that all animals entered in the AZSF are subject to blood, urine or tissue tests and that the AZSF reserves the right to disqualify any animal, either live or slaughtered, found in violation of the use of drugs, chemicals or feed additives as described above and in the AZSF Exhibitor Entry Handbook. Disqualification will result in the forfeiture of all class and sale premium monies, trophies, special awards and other consideration earned. If the animal is disqualified because of a positive test and/or the carcass is condemned at slaughter, the class placings will not be changed. We will allow the designated fair representative and/or veterinarian to draw any and all samples deemed appropriate from our animals. We will indemnify and hold harmless the AZSF and all of its sponsors and assisting organizations, their employees and agents, against all legal or other proceedings in connection with said drug testing. We will indemnify and hold harmless the show and its sponsors and assisting organizations against all claims for injury to any person or property caused by any animal. We also agree to pay all costs associated with testing, including, but not limited to veterinarian, laboratory, slaughtering and postage or air freight, if any animal is in violation of this provision.

ASSUMPTION OF RISK, RELEASE OF LIABILITY, AND AGREEMENT NOT TO SUE

In consideration of the permission to use the facility and services of Arizona State Fair (AZSF) for the 2020 Fair, I the undersigned, hereby expressly agree:

- THAT exhibiting animals is a physical, strenuous and potentially dangerous activity, as animals are unpredictable, and I am fully aware of the risks and hazards in or arising from my presence around animals and my presence upon the fair premises. I HEREBY ASSUME ANY AND ALL RISKS INVOLVED IN OR ARISING FROM MY USE OF OR PRESENCE UPON THE FACILITY, including without limitation, the risks of bodily injury including death, resulting from exhibiting animals, physical contact between myself and animals, or another person or a stationary object, or the negligent or deliberate act of another person or an animal. That large livestock shall remain in the care, custody and control of the exhibitor. The exhibitor shall indemnify and hold harmless Arizona State Fair and all of its successors, assigns, affiliates, officers, directors, employees and agents for any injury, property damage and any real, incidental, or consequential damages resulting from the large livestock or caused by the large livestock. Exhibitor agrees to defend any claim brought against the Fair as a result of the large livestock.
- THIS RELEASE shall be binding upon my heirs, administrators, executors, assigns and legal representative.
- TO WAIVE the protection afforded by any statute or law in any jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release;
- IF I IGNORE THIS AGREEMENT AND BRING A CLAIM, I WILL BE HELD RESPONSIBLE FOR ALL ATTORNEY FEES AND COSTS INCURRED BY AZSF.

Arizona Exposition and State Fair reserves the right to forward your name, address, and phone number to the media for purposes of promoting your entry and the Arizona State Fair. This entry is subject to the rules and classifications governing the exhibits as published in the current Premium Book, by which I hereby agree to be governed in exhibiting the same, and declare that all statements made in connection with entries are true. I hereby release the Arizona State Fair from any liability for loss, damage or injury to livestock or other property while said property is on the fairgrounds. Exhibitor hereby authorizes the Fair to use exhibitor's image and the image of his/her items entered in the Fair for purposes of promoting and educating the public regarding the wide array and talent exhibited within the Fair's Entries departments. Exhibitor is responsible for all copyrights and trademarks pertaining to the entries and agrees that any reproductions used to educate and promote the Fair's entries programs constitute "fair use" of copyright works. Entry is made subject to the approval and acceptance by the Arizona Exposition and State Fair Board.
