

Arizona Department of Revenue License Compliance Program



Arizona transaction privilege tax (TPT); commonly referred to as sales tax, is a tax imposed upon vendors for the privilege of doing business in the state. In order to be in compliance, a business that is selling a product or engaging in a service that is subject to TPT, will require a TPT license from the Arizona Department of Revenue (ADOR).

Businesses are required to file all their TPT activity with ADOR through a centralized reporting and payment system, which makes it easier to file one return per TPT license.
